A frequent question I hear regarding the Cherrywood Neighborhood Association is what does it take to be a member? The answer is simple: if you live in the Cherrywood Neighborhood, then you already are a member. Or, to put the answer in more obvious terms, if this edition of THE FLEA arrived on your front door step, then you are a part of the Cherrywood Neighborhood Association, or CNA for short.

Renters and homeowners alike are welcome to become involved in the CNA. Membership is free, and our meetings are open to all neighborhood residents. The CNA is not a homeowners' association. This means that we don't regulate the aesthetics of yards and homes, charge dues or levy fines, or foreclose on homes. These are things that a homeowners' association may do.

A neighborhood association like ours is different. For starters, we work with other neighborhoods through organizations such as the Austin Neighborhood Council and the Upper Boggy Creek Neighborhood Planning Team to provide input to city leaders on issues ranging from crime ordinances to local zoning changes. The CNA also provides feedback and input on zoning and land use proposals in Cherrywood.

For example, last month we appeared before the Austin City Council to support an ordinance allowing for vertical mixed use development on properties along our neighborhood's major corridors; i.e., Airport Blvd., Manor Road, and IH-35.

The CNA also works to build consensus for plans on how our neighborhood will grow. In February, after an extensive stakeholder input process that began last summer, the CNA adopted a neighborhood sidewalk plan. This plan identifies those streets where sidewalks are preferred, and those where they are not. The benefit of having this consensus-built plan is that it lets the City of Austin know our preferences with regard to actual sidewalk placement before it begins street reconstruction projects in our neighborhood.

Our Association's resume includes working with key Austin agencies on neighborhood concerns. We have been in contact with Capital Metro with regard to freight train traffic noise and rail crossing safety. Last year, we helped start a dialogue with the City of Austin and telecommunications service providers that led to the recent clearing of utility poles at the Cherrywood Green. In addition, we have worked on developing a relationship with the Austin Police Department to let them know of our on-going concerns about crime in our neighborhood.

Our next CNA general meeting will be on Wednesday, May 19 from 6:30-8:00 p.m. at Maplewood Elementary. This meeting will include a crime update from the Austin Police Department, as well as a presentation by City of Austin Code Enforcement officials on how a property can meet-or not meet-City code requirements. We'll also be discussing the City's plans for our greenbelt at Willowbrook Reach (see insert). As always, everyone living in the neighborhood is welcome and encouraged to attend.

## PROPOSED UPDATE TO CNA BYLAWS

everal proposals have surfaced that involve potential modifications to the bylaws of the Cherrywood Neighborhood Association, which are available on the CNA Web site at www.cherrywood.org (see "About the CNA"). Among several relatively minor changes, the question of official local business participation in our neighborhood affairs has been raised. This has many implications and has been a somewhat contentious issue in the past.

In order to more fully explore these issues, the CNA Steering Committee asked that Vice-Chair Aaron Choate chair a task force to discuss and propose any modifications that need to be made. The task force had its initial meeting on March 31 and has made the following recommendations:

- Recommend changing General Meeting frequency from "quarterly" to "at least quarterly."
- Explore the idea of having the UHaul property, currently in the Cherrywood boundary, and the old Academy property, currently in the Wilshire Wood boundary, be within both neighborhood boundaries; i.e., for us to overlap at those properties like we do with Patterson Park. Since there is a likelihood someday that a train station-either on the east or west side of IH-35 where the track crosses-and in either case these two properties will then be in a Transit Oriented Development district, we will have much more clout in dealing with this to the benefit of both neighborhoods if we work together. The suggestion was to contact Leslie Lawson, Chair of the Wilshire Wood Neighborhood Association, and ask that we have a joint task force between the two neighborhoods to explore this idea.
- Recommend changing the minimum age for membership from 18 years to 16 years of age.
- Recommend conducting an online survey to gauge CNA members' stance on the subject of an additional business membership category. CNA Steering Committee members Jack Newman and Girard Kinney will develop the two positions (pros and cons) as carefully as possible and then ask in the poll whether we should investigate the idea further or just leave it as it is at least for now.
- Recommend that the specifics about when and where public notice is provided be moved to a separate policy and referenced in the bylaws.

#### **MUELLER UPDATE**

On April 6, more than 100 people turned out for the Mueller Market District town hall meeting. Jim Adams of ROMA Design presented a brief history and listed things wanted by both Mueller and potential grocers. Attendees broke into small groups to give feedback on the grocery store, on the District's site plan, and on circulation and connectivity. While many felt they weren't needed, the fuel pumps wanted by the grocer seem certain, but the pump's design and location was a hot topic and seemed to be well received by Catellus and ROMA.

Catellus hopes to announce the grocer sometime this year, and to break ground on the Market District by early next year. That will include the extension of Berkman Drive into Mueller, which will connect with the Berkman portion already in place off of Manor Road.

The March traffic counts done by the City at 38 locations in and around Mueller are still being evaluated. City staff will present the collected data at the May Mueller Commission meeting, though this count was primarily to establish a baseline for future counts taken while Mueller is developed. Interestingly, these counts are unlikely to result in traffic signals being installed at busy intersections. State law designates traffic levels required before signal installation, and the City typically waits till complaint calls alert them to a problem.

Pedestrian, bike and auto traffic patterns at Mueller will evolve as the site is built-out over the next several years. Now lacking in several places, once completed, most major streets in Mueller will have bike lanes or on-street bike routes, with Barbara Jordan Blvd. being an exception. A roughly seven-mile pedestrian trail will encircle Mueller. ROMA defines "trail" to include a wide sidewalk along 51st Street, already in place by Home Depot and on the UT block.





### CHULA: Springing Forward with New Board Member and Projects

CHULA (Cherrywood Urban Landscape and Arts League) held its annual membership meeting in February, where members in attendance elected the Board of Directors, received an update on finances and current projects, and recommended projects for 2010. At the meeting, Melanie Chasteen provided an update on the status of the traffic island landscaping on East 38th½. The City of Austin is requiring that CHULA submit an Adopt-a-Park application before proceeding. Look for progress and a call for volunteers coming soon.

The CHULA Board met again in March to elect officers and decide to focus on the following projects this year by:

- partnering with FRoG to hold a garage sale fundraiser benefitting the Friends of the Green, which was a success (see page 5);
- creating a talent database on the CHULA Web site for CHULA Triangle-based artists and landscape talents;
- creating a gardening project in possible partnership with either Mueller and/or the Maplewood PTA;
- partnering with the Vortex Theater to support a common space for neighborhood artists during the East Austin Studio Tour;
- exploring a public art project along the train tracks on Clarkson Avenue; and
- gearing up for the 2010 Cherrywood Art Fair and on-going Little Artist/ Big Artist project. CHULA needs volunteers to help coordinate the following Cherrywood Art Fair positions: Food Management, Demo/School Art, Volunteer Recruitment, Setup/Breakdown. We are also in dire need of someone to help Jane Walton manage the Little Artist/Big Artist program next fall. Come be a part of a great team!

# Planning, Zoning & Transportation Update

CNA PZ&T Committee Chair

Recently, Cherrywood's Planning & Zoning and Transportation Committees merged to create the Planning, Zoning and Transportation (PZ&T) Committee. Members of both committees are automatically included in the newly formed committee. Here is the status of items currently underway by the Committee:

#### VERTICAL MIXED USE (VMU)

All but a few properties in our neighborhood have received the final VMU designation, which City staff recommended and which both the CNA and Upper Boggy Creek Planning Team recommended several years ago and again last fall. A meeting about the property at 4020 Airport was originally scheduled for April 22, but has been postponed until May 13. If that property does receive the VMU designation at the May City Council meeting, the extensive deed restrictions on the property will still exist, and represent good leverage for the neighborhood to be consulted by any developer in order to ensure that any proposed development meets not only the developer's goals but also addresses neighborhood concerns and provides neighborhood-oriented uses.

#### STREET RECONSTRUCTION

The previously reported street reconstruction project, which involved rebuilding several streets in the boundaries of CNA, is in the early design phase. The neighborhood will most likely host a specially called meeting to receive a presentation when the project is at the 30 percent completion stage. A map of the proposed streets, which was previously published in the

November 2009 issue THE FLEA, is available online at cherrywood.org. We will also have presentations at the 60 percent and 90 percent points. Construction is planned to begin mid-2011.

#### SIDEWALK PLAN

The CNA gave final approval to the Cherrywood Neighborhood Sidewalk Philosophy and Master Sidewalk Plan at its last general meeting in February. The final version of both the Philosophy and the Plan is available online at cherrywood.org.

#### SIDEWALK IMPLEMENTATION

We have been assured by City of Austin officials that our Sidewalk Plan will guide the construction of sidewalks in our neighborhood, which includes those sidewalks built in conjunction with the streets contained in the Street Reconstruction Project. Since our plan actually saves the City well over \$2 million in the cost of sidewalks that would have been required in their original street reconstruction plan, the CNA has additionally requested that they consider building out most, if not all, of the sidewalks in our Sidewalk Master Plan. We are awaiting their decision about whether their project can be expanded to include additional streets for the purpose of building sidewalks and, if so, how much of our sidewalk plan could be implemented in the current project.

#### SIDEWALK PRIORITIES

In the likely event that not all of the sidewalks in our plan can be constructed, we communicated our sidewalk priorities to the City, which include, in this order: (1) filling in missing gaps and eliminating barriers to accessibility along our existing sidewalks, (2) sidewalks directly providing access to Maplewood Elementary School, (3) sidewalks that connect the sidewalks that will be built along the reconstructed streets with the Manor and East 38th½ corridors, and (4) all other sidewalks in our plan.

### CLEAN SWEEPING

#### AT WILLOWBROOK REACH

Thanks to all the great volunteers who came out Saturday, April 10, to clean up Willowbrook Reach, your neighborhood greenbelt at Cherrywood and Sycamore. Nearly two dozen neighbors got down and dirty picking up litter at the annual Clean Sweep sponsored by Keep Austin Beautiful. A great time,

and great snacks, were had by all as

we hauled 10 bags of trash out of the creek, including one bag of recyclables. With new leaves on the trees and wildflowers popping, the greenbelt is now shined up and ready to put on its spring show. Pretty soon, if you wander by at dusk you might glimpse a heron or catch a firefly spectacular. Enjoy!



#### It's Property Tax Time Again

Spring in Austin is beautiful for it's soft rains, greening landscapes and the fragrance of all things that bloom. But it's also property tax time and with that comes the opportunity for each of us to challenge our tax appraisal. The process can be intimidating and unsuccessful if you don't understand ins and outs when it comes to effectively convincing appraisal authorities to lower your property values. So I'd like to offer a few tips to help explain the four basic appraisal cycles.

- 1. This first cycle runs from the first of the year through May 31st. During this time, appraisal districts appraise the properties in their districts, give notice to property owners and receive protests.
- . 2, The second phase is when the district schedules informal meetings and formal hearings on the protested properties.
- 3. The third phase begins about the end of July. During this period, taxing units set their tax rates for the next year and post notices of public hearings regarding these tax rates.
- 4. Finally, the tax assessor-collector calculates how much each taxpayer owes, prepares and sends bills, collects monies due from each taxpayer and disburses the fund to the appropriate taxing units.

We all understand that city, county and school services depend on our tax dollars and I'm sure everyone wants to pay their fair share. But we often find that the actual process of appraising properties is extremely challenging in neighborhoods such as Cherrywood, or any older inner city neighborhood. So if you think your taxes are not in line with those of your neighbor or the vicinity, you may want to file a formal protest. 
