Date: October 19, 1996



Summary of the August 15 meeting

The Cherrywood Neighborhood Association met August 15 at Asbury United Methodist Church. About 20 neighbors attended and Buzz Avery presided.

Tree-trimming by the electric utility

Jerry Favel, a representative of the City of Austin Electric Department spoke about tree-trimming around utility lines.

Because of last year's severe storm and the resulting large number of branches which fell into power lines, the electric department's new policy is to cut back *five* years of growth on trees near lines and to *remove* obstructing trees which cannot be reasonably trimmed.

The city has contracted with Blume Tree Services to do the trimming, and they will be working on and off in our heavily forested neighborhood.

Mr. Favel said that the city attempts to notify residents of impending trimming by leaving notices on doorknobs and marking trees targeted for removal with bright pink ribbons.

If you receive such a notice and are concerned about your trees, you can call the City of Austin Tree Line at 322-6455 or our neighborhood tree inspector at 750-5146.

ACC East Austin campus

Buzz announced that he had received a letter from Austin Community College about their plans to build an eastside campus. ACC is inviting the public to participate in the early stages of the process and held an open meeting at the Carver Library on August 27.

More meetings are sure to follow, so keep your eyes open and call ACC if you want to have a voice in its east side campus selection and planning.

Airport update

Gerard Kinney, one of Cherrywood's representatives on the Mueller Airport Redevelopment Task Force, described the City Manager's slow pace in reviewing the task force's recommendation for an independent airport redevelopment authority.


The City Council appears to support the idea, but is awaiting staff review. The longer the City Manager holds on to it, the more momentum the idea loses.

Gerard thought that a formal letter from the CNA in support of the separate management entity might help. A brief letter was drafted and a unanimous vote was taken to send it to the City Manager's office.

PROPERTY OWNERS OPINION POLL

Subject: Possible Creation of a Neighborhood Conservation Combining District (NCCD)

It may be in the best interest of Cherrywood Neighborhood to create a NCCD. If a NCCD is created, legal changes will be made to the City of Austin Land Development Code that will <u>permit and/or restrict how land is used</u> in the area currently covered by the Cherrywood Neighborhood Association (CNA). But before going any further with developing a NCCD, it has been decided to survey property owners to see if there is sufficient interest to continue with the project. The following summarizes the pros and cons of an NCCD.

Pros: Changes to the land use Codes would require or recommend uniform neighborhood standards for all property. The purpose is to preserve the present character of the neighborhood while removing some restrictions on land use that discourage a "sustainable" community. Possible changes may include more of mixing homes with businesses, allowing detached duplexes, setting architectural standards, creating micro-parks, or establishing landscaping guidelines. Owners may exclude their property from the NCCD.

Con: Existing land use Codes are sufficient and work fine. Private property owners know what's best for their property and shouldn't be required to conform to unique neighborhood standards. To some degree, legal procedures already exist that allow property owners the means to control and change how their land is used. Variances from code requirements can be requested from the Planning Commission or from the Board of Adjustment. There, disputes between adjacent property owners can also be resolved.
