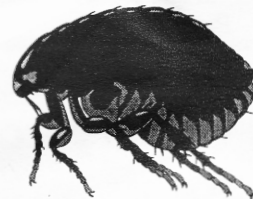

## CNA recommends site for electrical substation

On March 25 and 29 the CNA held two Emergency Meetings to ask the membership to recommend a site for the proposed Austin Energy electrical substation. While the Steering Committee acknowledges that the last several months of negotiations with Austin Energy have been rocky, I believe the end result is a good one.

A quorum of CNA members attending the Emergency Meetings voted in favor of the following motion: "The CNA Steering Committee recommends to the General Membership of the CNA that a proposed Fiesta/Delwood site (approximately between Pinky's Pagers and Blockbuster Video) be favored for the proposed new Austin Energy substation, given the information received to date. Should the Fiesta/Delwood site become unfeasible for any reason, the CNA Steering Committee shall recommend alternatives to Austin Energy. Mitigation and improvements to be provided by Austin Energy to the CNA shall be negotiated."

The Steering Committee considered several sites before favoring the one near Fiesta. The other proposed sites were deemed more damaging to the neighborhood in terms of large

power poles, residents in close proximity, etc. Photos of the other proposed sites and their projected impacts will be available at the general meeting. Few people want a new substation in our area, but we are the people who will benefit from it.

Austin Energy has already begun negotiations with the owners of the Fiesta site. If for any reason this site becomes untenable or our understanding with Austin Energy changes, the Steering Committee will start over with Austin Energy to identify suitable sites.

Perhaps the silver lining is that Austin Energy will fund improvements to the neighborhood immediately around the proposed site [see Mike Damal's related article]. This process will unfold over the next several months. If you want to get involved in the mitigation negotiations, call Mike at 478-9622.

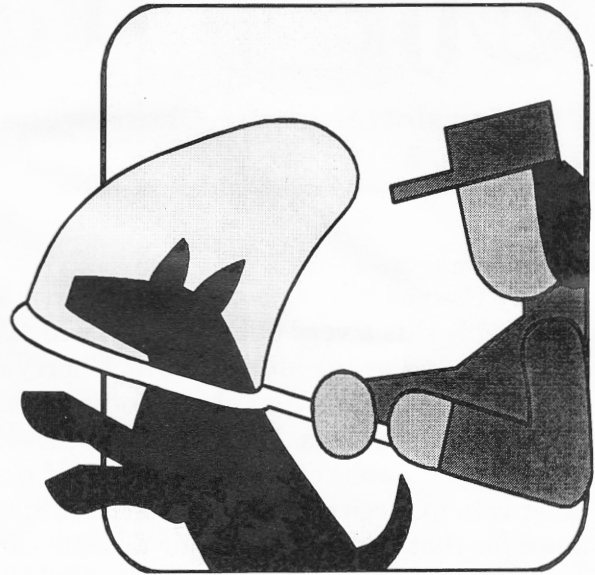

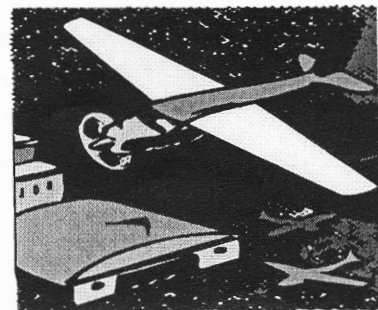

## Historic Mueller hangar recalls WWII shortages

An interesting bit of neighborhood history stands silently behind barricaded gates across Airport Boulevard from Patterson Park. Mueller Airport's wooden aircraft hangar, the airport's second hangar, was built in 1943. Its significance is primarily architectural. Due to wartime shortages of metal, it was constructed of 1x10 yellow pine planks, laminated onsite, laboriously crafted, and then hoisted into place. Such World War II-era wooden hangars are extremely rare. Researchers at the state and local levels are currently investigating how many were built and how many remain. Our hangar may quite possibly be worthy of a listing in the National Register of Historic Places.

It is noteworthy that the latest development plan for the Mueller site calls for preserving the hangar at its present location, the only onsite structure so designated. However, some city staffers favor its demolition or relocation to another site, possibly Bergstrom. If you strongly favor, as I do, onsite preservation of this vestige of the seventy year-old institution that literally put our neighborhood on the map, please make your opinion known to neighborhood leaders or contact the City Council by mail, phone, or over the internet at <http://www.ciaustintx.us/council/officials/htm>.

## Neighbors can do something to make Cherrywood safer

Summer is approaching, and that can often mean a seasonal increase in crime. But every CNA resident can take actions to keep Cherrywood as safe as it can be.

To begin with, do not hesitate to communicate all your safety concerns to our district representative Carlos Casas (phone 926-9932, fax 933-9010). Officer Casas is the APD liaison for Charlie Sector in which Cherrywood falls. He can arrange for officers to investigate criminal activity in the neighborhood; he also transmits neighborhood concerns to his commanding officers which can result in increased patrols and overall police presence.

The CNA Steering Committee also has a crime liaison who keeps track of security issues. Kathy Jones is currently serving in this position and would welcome your thoughts and suggestions. She can be reached at 472-1921 or

The intimidation of neighbors by oddly-behaving men [see Kathy Jones's article] cannot go on, and regardless of how busy we all are, there are certain things which everyone should do if they observe strange or threatening behavior:

(1) **Report** every incident, no matter how ambiguous it may seem. No file means no APD attention. Tell any 911 operator who might downplay the urgency of your call that your "District Officer told me to report this sort of thing, so please take this report."

(2) **Record** everything that you can remember about the incident. This would include descriptions of the person, dress, vehicle, time, place, and any words that were exchanged. Write things down immediately while details are still fresh in your memory. Give Kathy Jones a photocopy of your report.

(3) **Post** a summary account of the incident on the CNA listserv if possible; encourage

neighbors who have had incidents to do the same.

(4) **Log** everyone's response to your report. This includes 911 operators, APD officers, and CNA members. With whom did you speak, when, and what was said?

Such fastidious record-keeping is the only thing that will cause APD to take real organizational action. APD will simply never respond to vague verbal reports as well as they do to careful written ones. Moreover, a paper trail will help CNA get results. Officers know that we will take our records to Chief Knee if necessary.

We can end to the intimidating behavior of criminals, drug addicts, and threatening individuals in our neighborhood, but we all have to take our responsibilities seriously.

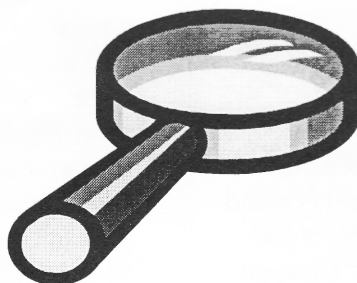
## Cherrywood Crime Watch

There have been a number of burglaries in the neighborhood in recent months, including one break-in which occurred while the residents were at home sleeping. We are still also experiencing car break-ins. APD District Representative Carlos Casas has asked everyone to be on the lookout for suspicious

individuals and vehicles. Make note of the license plate numbers of any cars that are driving slowly and seem to be casing homes. This includes requests for more street lighting.

One particular area of concern recently has been the Boggy Creek Greenbelt. This is the sweet little greenbelt that starts at Cherrywood Road and continues eastward bordered by 40th Street on the north and Sycamore on the south. On April 4, a man behaved in a disturbing manner toward a mother and her three children. He persistently stared at them in a "weird" way. Each time they tried to walk in a different direction, he would pull his car in front of them, get out,

## REBECCA'S HOME OWNER'S UPDATE

### Spring Gardening Tips

Spring 2000

#### Rub Out Pests

Houseplants bothered by pests? Rub them out with rubbing alcohol. Gardener Dominique Inge of Granbury, Texas, finds this recipe effective against mealybugs, whiteflies, red spider mites, aphids, fungus gnats, and scale. She cautions that it may cause leaf burn on some plants and doesn't recommend it for African violets.

#### Ingredients and Supplies

½-1 cup rubbing alcohol  
1 quart water  
Pump spray bottle

#### Directions

1. Mix ingredients in a pump spray bottle.
2. Test spray on a leaf to check for burning.
3. Wait 1 day and check for damage before treating the entire plant.
4. Treat at 3-day intervals for 10 days or as needed. Don't use this in the heat of the day.

**Yield:** 4½-5 cups of alcohol spray

and stand near the creek so that they would have to pass him. When they changed direction to avoid him, he would do the same thing again. This happened three or four times before he finally disappeared. He is a tall, thin black man probably in his thirties and without facial hair. He was smoking a cigarette, and his pickup truck was a black or dark gray Nissan.

I myself encountered a similarly threatening individual on the greenbelt just two days later on April 6. He seemed to be high on drugs and casing homes; he harassed a neighbor walking her dog. We called 911. This individual was an African-American male seemingly in his early 20s, about 6 ft., with a red knit cap, white t-shirt, and new-looking blue jeans.

Although nothing "happened" in either of these two encounters, observation and intuition said they were dangerous situations. We all need to be alert and aware of our surroundings at all times.

## Mueller master plan gradually taking shape

The ROMA Design Group of San Francisco is working toward a final master plan for the former Mueller Airport and says that it should complete its work some time in May.

As of now, the draft of the plan includes 1,765 single-family homes and townhouses, 3,315 apartments, condominiums, and stacked flats, 320,000 square feet of retail space around a town center, 2 million square feet of office and manufacturing space, a 12-acre lake surrounded by walking trails, and other sites for a school, parks, greenbelts, and an Austin/Travis County Emergency Command Center. The draft plan preserves the WWII-era wooden hangar near Airport Boulevard [see article by Sharon Edmonson].

One of the ROMA's most controversial suggestions is to hand development over to a private master developer who would theoretically implement the master plan. The Mueller Neighborhoods Coalition (MNC) has traditionally favored a publicly run development corpo-

ration to oversee redevelopment. Such a public corporation would presumably be more responsive to neighborhood pressure to obey the plan as drafted by ROMA. One fear is that future city councils might allow a private developer to deviate from the master plan.

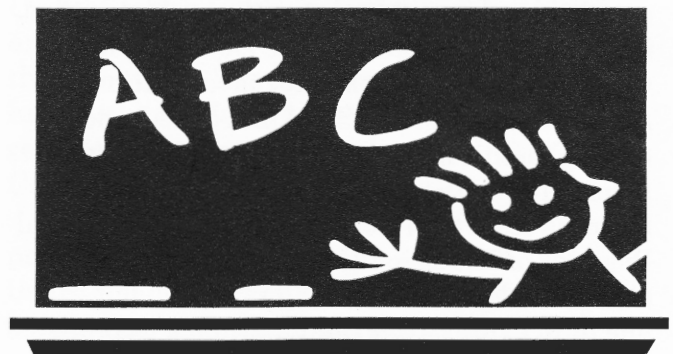
The City Council plans to vote on the master plan in June, assuming that all deadlines are met on time. MNC will continue to lobby for ROMA's master plan for this huge area next to Cherrywood. See Jim Walker's related article on page 8 which explains the MNC's current position.

Superintendent Forgione has suggested that some "low-enrollment schools" might be consolidated with larger schools. There have also been suggestions for more cut-backs for physical education and the arts. I don't mean to sound alarmist, but if we don't continue to speak in support of our school, we may lose something of great value. I urge you to let the AISD administration know that we support Maplewood.



## Planning and Zoning Committee Update

The CNA Planning and Zoning Committee has been busy with neighborhood issues. In particular, we are addressing the following:

**(1) Improvements to accompany substation.** Austin Energy has said it will help Cherrywood with physical improvements to compensate for the substation to be built in our neighborhood [see related article by Jim Walker].

Some of the preliminary ideas for improvements which the P&Z Committee has "brainstormed" include (1) moving the bus stop at 38½ St. and Robinson to the other side of the street so that shoppers don't have to cross 38½ St., where they frequently leave their carts and other trash, (2) better landscaping along 38½ St., (3) electrifying the new Maplewood School sign, (4) purchasing entrance signs to Cherrywood, (5) burying utility lines on 38½ St. to improve its appearance, (6) building a "garage-sized" community meeting room next to the substation, (7) purchasing new greenspace to offset the loss in pervious cover due to the substation, and (8) improving sidewalks on 38½ St. and other adjacent streets.

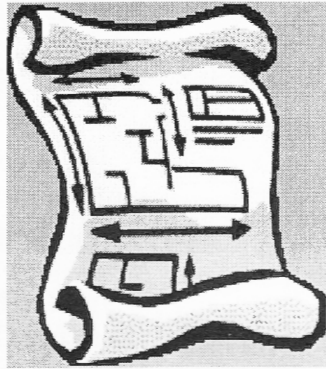

**(2) Expansion of Children's Advocacy Center.** The Children's Advocacy Center (CAC) is planning to add an upper story to its garage outbuilding adjacent to the Avalon Apartments on 32nd St. Since the CAC property is zoned "neighborhood office - historic", it is required to go through the city's Landmark Commission for any exterior modifications. According to Barbara Stocklin of the Landmark Commission, the CAC is applying for federal funds that if used would prevent the building from ever being listed on the National Register of Historic Places. Barbara said that she would look more deeply into this, but that she didn't think that the Landmark Commis-

sion would have any problems with the second story or the lead paint abatement that is planned. The P&Z Committee will notify residents of the CAC's appearance before the Landmark Commission via email/website as soon as it has been scheduled. **(3) Future of Value Sky Park.** The P&Z Committee is also researching the land at the Value Sky Park on Manor Road. This land has various restrictions on its development, and we are looking into how these restrictions could affect future development and surrounding neighbors. Austin is in a building boom, and this land will be developed, probably sooner than later. We feel it is better to be proactive rather than reactive to a proposed development.

## I-35 Update

TxDOT long-range planning for the future of I-35 continues, although no new information has been released for several months. A coalition of neighborhoods abutting the east side of I-35 is currently being organized by the CNA Traffic Committee. This coalition will ultimately provide information and recommendations to the Steering Committee about how to influence the expansion process most effectively.

All three of the schemes currently under serious consideration would take 60 feet to 100 feet of additional Right of Way along the entire portion of I-35 abutting Cherrywood. The scheme that least impacts our neighborhood in terms of property takings, visual impact, and noise abatement would depress the main lanes of the freeway (the same as proposed downtown), leave the west upper deck open for High Occupancy Vehicle (HOV) lanes, and remove the east upper deck completely.

## City plans to dig up Lafayette this summer

City crews are scheduled to perform water main and street construction on Lafayette between 26th/Dean Keeton and Edgewood some time this summer. Disruption should only affect the street itself, but crews are supposed to repair any damage they do to front yards. The city will first replace the water line; then it will do street repair. A survey in preparation for this work was completed last summer (remember the stakes and pink ribbons?). Final construction plans were approved in January, and the job is on the list - of course, so are many others.

## Traffic calming petition exceeds expectations

Thanks to many CNA volunteers, our traffic calming petition received 550 signatures, exceeding our initial goal of 400 signatures.

The petition itself, was presented to the City Council on March 2 as a 60-foot-long scroll. We also sent copies of the petition with a cover letter outlining our concerns to Traffic-calming Program Manager Joan Hudson, City Manager Jesus Garza, and State Representative Dawnna Dukes. News 8 Austin interviewed Helen Kent-Davis and several other neighbors about our traffic problems, giving the issue TV coverage.

We remain cautiously optimistic that all our work will result in traffic calming for the neighborhood this year. We are now trying to determine which neighborhoods will be selected. The Traffic Committee will report as necessary.

Selection as a traffic-calming neighborhood is only a preliminary step. Cherrywood neighbors have to approve the city's proposals before any concrete is poured. Neighbors will work hand-in-hand with the city to determine which traffic controls are appropriate; then residents of the affected area will vote on the plans.

Again, thanks to all of you who pounded the pavement gathering signatures, signed the petition, or contacted Joan Hudson with traffic concerns. A big thanks to Helen Kent-Davis who spearheaded this tremendous effort.

If you have not yet called Joan Hudson about your specific traffic concerns, it's not too late. Please call the city transportation department at 499-7012. Your voice might be the one that puts us over the top and ensures traffic calming this year.

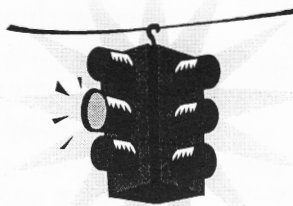
## Longhorn Railway gets the boot

A few years ago I wanted to do a piece in *The Flea* to educate neighbors about the railroad that runs through our neighborhood. I called Don Cheatham, the owner of Longhorn Railway, to ask him some questions on how the railroad right-of-way was maintained. Instead of cooperating, he told me angrily that the tracks were there before I was and threatened to call his lawyer. I remember thinking that I was glad that I didn't have to deal with this man in my everyday life. Well, it looks like Capital Metro, which owns the tracks, has come to the same conclusion.

According to a March 9 article in the *Austin American-Statesman*, the Capital Metro board has canceled Longhorn Railway's contract to use the tracks, because Longhorn has allegedly not maintained them properly (remember the derailments a few months ago?). Cheatham, who has already sued Capital Metro board member Daryl Slusher for preventing him from making a living, blames Capital Metro for the maintenance problem and vows not to give up without a fight. For the meantime, however, another rail company has been brought in to finish the six months remaining on Longhorn's contract. After that, Capital Metro will assess the situation.

Is it possible we may have a freight company willing to respect the neighborhood instead of disdaining it? Things at least look better than they did a few weeks ago.

## CNA alerted to rumored Mueller land swap

Local media have reported a possible land swap involving development rights at Mueller for land over the aquifer owned by Stratus Properties (formerly FM Properties). For several months, as the city negotiated the Bradley Settlement over the aquifer, it became apparent that soon after that deal was done other developers such as Stratus would come to the City looking for similar settlements.

The Mueller Neighborhoods Coalition (MNC), comprised of 14 separate neighborhood associations around the old airport, has held that any negotiations involving the Mueller property must meet the following conditions:

- the ROMA masterplan is adopted and the site rezoned accordingly;
- a development corporation or similar oversight entity is created and appointed with appropriate neighborhood representation;
- an open, public process of selecting a major

financial partner, such as a master developer, to implement the Mueller redevelopment masterplan.

The MNC sent the following two-point statement to city councilmembers two weeks ago on this issue:

"Amidst persistent and disturbing rumors of a deal being negotiated between the City of Austin and Stratus Properties/Tom Hicks involving the Mueller site and land over the aquifer and/or a cash swap, we must make two statements:

1. Any and all negotiations with any party regarding development rights to Mueller must be halted immediately.

2. If a master developer strategy is chosen as the method of land disposition for Mueller, then an open and public process must be used to select the master developer."

Residents of the neighborhoods around Mueller, including CNA, may need to appear en masse at a City Council meeting in early May. We'll know more on April 26, or call Jim Walker, Girard Kinney, or Gordon Bennett.
