CodeNEXT Looming!

he CNA Land Use and Transportation (LUT) committee continues to work on the process by which we respond to upcoming construction and transportation projects in the neighborhood, but most of our recent activities have been focused on CodeNEXT. We need more participating members; please consider joining the LUT Committee.

We recommended, coordinated and participated in the Special Called Meeting at Maplewood Cafeteria on August 29th where Mayor Steve Adler and Mayor Pro-Tem (and our District 9 Council Representative) Kathie Tovo were our guests; Jim Reed, CNA Steering Committee (SC) Chair facilitated.

An online survey was conducted prior to the meeting with active participation and presented at the meeting. It indicated that about half of the people polled had "limited" understanding of how CodeNEXT would affect our neighborhood and roughly half with "basic understanding." Participates indicated that the reasons for "limited" to "basic understanding" were related to the frequent changing of the zone maps, confusing zoning terms, and overall poor presentation by the city. The concern was also expressed that CodeNEXT is unbalanced in regards to incentivizing densification in the interior residential area with minimal incentives for densification along our business corridors.

An estimated 150 attendees heard introductory presentations by our guests, then Q&A from our four person panel, and finally questions posed from the audience. Topics ranged from understanding the new zoning

categories to concerns about local residentialand corridor impact of CodeNext to where we are in the process. Both the Mayor and Mayor Pro-Tem stated that they could not support the CodeNEXT proposal as currently written, but both acknowledged that our land development code is antiquated, hard to use and needs to be revised.

The Mayor stressed the need for more compact development, more housing choices particularly along nodes and corridors, and adoption as early as April 2018, while the Mayor Pro-Tem inclined toward take the time to do it right. Our guests promised to return after the next draft has been published and analyzed by the community.

There is consensus among the LUT Committee members that there remain serious flaws in the proposed code with respect to its potential impact on Cherrrywood, and we hope that our remaining concerns will be addressed in future iterations. After the Draft3 CodeNEXT version is published,

possibly late Nov, we plan to have an informational Special Called Meeting, where we will attempt to formulate our next organized input into the CodeNEXT process, before requesting another meeting with Mayor and Mayor Pro-Tem.

Please review the CodeNEXT table on page 3, which draws comparison of the current SF3 zoning to the proposed R2C/ R3C residential. We urge all Cherrywooders to become involved in the community conversation about the needed change to our City Code. It is undeniable the quality of life in our neighborhood is tied inextricably to this looming change in our Code.

riends of Patterson Park has developed a Neighborhood Park Plan that is intended to guide our work in the coming years. It is considered a "dream plan," the vision for improvements to the park not just now, but 10 and 20 years from now. The plan is based on the 2016 Survey of Community Priorities for Patterson Park and community meetings held in June and September 2017. It was developed using guidelines from the City of Austin Parks and Recreation Department.

This fall the plan will be presented to the City of Austin Parks and Recreation Department, the Cherrywood, Delwood 2, Mueller, Schieffer Willowbrook and Wilshire Wood/Delwood 1 Neighborhood Associations for approval, as well as to the Upper Boggy Creek Neighborhood Contact Team.

Thanks to community support, the proposed microplayground near Lafayette and Dean Keeton was unanimously approved by the CNA at the general meeting in August. While the space is small, proposed features included new native trees, a small playscape, an herb and butterfly garden, ADA access, and a pool-code fence. As discussed at neighborhood meetings, the City will be funding the vast majority of the park's construction with the commitment of neighbors to maintain our new green space after construction. Maplewood Celebrates 65th anniversary

Maplewood Elementary is turning 65, and is celebrating with a new piece of public art, some fresh landscaping, and a commemorative illustration of the school. Chris Levack, who created the Rocket Ship and Pollen Grain at Mueller and is the father of two Maplewood alumni, created Peace Sculpture (steel) and installed it at the entrance this summer. In September the school celebrated it's anniversary and the new sculpture with a morning birthday party attended by members of the AISD board, several media outlets, and many neighbors and alumni. The sculpture was donated by Nicolas Colimon, Mustang Class of 2017.

More changes were implemented to the school's exterior in October. Through a partnership with the nonprofit Austin Partners in Education, the Austin office of Ernst & Young LLC gave Maplewood a \$2,000 grant and held a volunteer work day to install new landscaping at the school entrances. Urban Patchwork created a landscaping plan, Keep Austin Beautiful loaned us tools, and Organics by Gosh donated mulch and compost. Eighty volunteers worked a half day at the school on October 6, transforming the exteriors facing Maplewood Ave. and Ashwood Rd. Stop by and check out our new look! 

At my first tour, the very first tour in 2003, I was invited by my dear friend and fellow painter Pablo Taboada to show some work at his studio Art Amici on San Marcos St. Back then, the tour was only one weekend in November, and it was all bikeable! There were 28 studios and they were only makers' spaces. You got to see the space where the art was made. Over the years, the tour has grown with more studios and more artists. In 2010, there were 150 studios and 340 artists showing their work.

Now, in 2017 there are 495 studios plus several East Austin libraries participating. The tour has put Austin on the national map as an art destination, and Cherrywood has become an EAST mecca over the years. In 2009, I hosted EAST in my home studio for the first time. Having been part of the bustling area of studios around East Cesar Chavez St., where our studios got a lot of foot traffic, I was a bit discouraged at how quiet my studio was that year. It was hard to compete with the large art complexes and clusters of home studios further south. But that changed. As the tour has continued to grow, more and more artists are populating our neighborhood, and Cherrywood has become an EAST destination. It is wonderful to be able to send my visitors to my artist neighbors' spaces and to hear that many of them have come to my studio after already having been at another art studio in the neighborhood. There are now 18 Cherrywood studios on the tour!




